RE: Honor the Chief Society, Inc. -- Service Mark Application for CHIEF ILLINIWEK and Other Trademark Matters

Dear Mr. Bolin:

We represent the University of Illinois. We are contacting you with respect to several matters related to the use by your client, the Honor the Chief Society, Inc. (the "Society"), of the "Chief Illiniwek" name and other trademarks of the University of Illinois.

We note that you filed an application (Serial No. 77/784714) on behalf of the Society to register the mark CHIEF ILLINIWEK in the United States Patent and Trademark Office ("USPTO") in connection with: "Dance events; Dance reservation services, namely, arranging for admission to dance events; Entertainment and education services in the nature of live dance and musical performances; Entertainment and educational services, namely, the presentation of seminars, lectures, workshops and panel discussions, and ongoing television and radio talk shows all in the field of public interest concerning Native American culture; Entertainment in the nature of dance performances; Entertainment in the nature of visual and audio performances, namely, musical band, rock group, gymnastic, dance, and ballet performances; Organization of dancing events; Organizing community festivals featuring a variety of activities, namely, art exhibitions, heritage markets, ethnic dances, and the like; Organizing community festivals featuring a variety of activities, namely, sporting events, art exhibitions, flea markets, ethnic dances and the like; Organizing community sporting and cultural events."

We further note that the Society's website offers various merchandise using the name "Chief Illiniwek" and the "ILLINI" trademark. Specifically, we note that the Society's website is offering posters using the "Chief Illiniwek" name (i.e., "Chief Illiniwek Poster – Memorial Stadium" and "Chief Illiniwek Poster – Assembly Hall") and a pin using the "Chief Illiniwek" name (i.e., "Chief Illiniwek Pin") and bearing the ILLINI trademark. A print-out of the web page showing this merchandise is attached for your reference.

The University of Illinois did not authorize the use of the Chief Illiniwek name or the ILLINI trademark in connection with the sale of these items by the Society. The CHIEF ILLINIWEK name has been associated with the University of Illinois since 1926, and the University of Illinois has used the CHIEF ILLINIWEK name and related marks as trademarks in connection with numerous goods and services. Any use of the CHIEF ILLINIWEK mark or other trademarks of the University of Illinois by the Society in connection with the services listed in its application or the merchandise offered on its website will cause confusion as to the source of such services or goods. Such use will also cause the public to mistakenly associate the use of the CHIEF ILLINIWEK mark and other trademarks of the University of Illinois in connection with such services and goods with the University of Illinois or mistakenly believe that the University of Illinois has licensed, sponsored or otherwise approved of the Society's services and goods.

Lastly, we note that the Society's website refers to "booking information for a Chief Illiniwek performance" and the website reprints the Students for Chief Illiniwek press release which includes the statement: "Chief Illiniwek XXXVIII, UI Sophomore Ivan Dozier will address the media..." Copies of the web pages with these references are attached for your reference. These references are false and misleading because the University of Illinois has not authorized these performances or appearances.

Therefore, the Society's use or registration of the CHIEF ILLINIWEK name and other trademarks of the University of Illinois as described above constitutes infringement of the University of Illinois' common law trademark rights in violation of federal law (15 U.S.C. § 1125(a)) and applicable state law; trademark dilution under federal law (15 U.S.C. § 1125(c)) and applicable state law; and, unfair competition and false association under federal law (15 U.S.C. § 1125(a)) and applicable state law; and applicable state law.

Accordingly, we hereby demand that the Society:

- 1. Withdraw trademark application Serial No. 77/136902;
- 2. Remove the reference to the "Chief Illiniwek" name in connection with the posters and pin offered on the Society's website;
- 3. Cease and desist from sale of the pin bearing the ILLINI trademark;
- 4. Remove the references on the Society's website to performances or appearances by "Chief Illiniwek" and cease and desist from any similar statements;

5. Provide us with written assurances that the Society will not use, and will cease any use of, the "Chief Illiniwek" name or other trademarks of the University of Illinois on its website, in connection with any goods or services, or in any other manner that will be likely to cause confusion with the University of Illinois.

We remain hopeful that this matter can be resolved amicably. However, please be advised that if your client does not comply with the above demands, we will oppose application Serial No. 77/784714 and take such other legal actions as are necessary to protect the "Chief Illiniwek" name and the University of Illinois' other trademarks.

We look forward to your response.

Council of Chiefs to Announce Chief Illiniwek XXXVIII Monday Ul Sophomore sees Chief as education tool on Native Culture

The Progressive Registered Student Organization Students for Chief Illiniwek announces its sponsorship of a major announcement by the Council of Chiefs, a group of Alumni who portrayed the Chief Illiniwek symbol as students at the University of Illinois, on Monday. May 3<sup>rd</sup>, at 11 AM at the Alma Mater Statue at the Urbana campus. Chief Illiniwek XXXVIII, UI Sophomore Ivan Dozier will address the media on his Tole portraying the Chief and will ceremonially accept the Illiniwek regalia from current portrayer Logan Ponce.



Dozier, of Ivesdale, Illinois, will be assisted by Katie Birkel of Peoria. Illinois the first woman to portray Illiniwek since Idell Stith Brooks filled the role as "Princess Illiniwek" during World War II. Dozier stated his hopes to bring fresh perspective to the Chief dialogue, "I hope to use the chief to educate people about Native culture," he said. Education on Native culture is important to Dozier, who is half Cherokee through his falter, and he hopes to establish a working relationship with the University's Native American House, which has vehemently opposed the tradition in the past.

At Monday's event both Dozier and Birkel will address their hopes for the future of the Chief Illiniwek tradition as well as efforts to further educate students on campus about the tradition's roots and inportance to the University. Dozier expressed his dismay at the Chief's removal from the campus, "To see that taken away, it's like taking away some of the glue that holds our great institution together: it seems like there's less unity on campus with the Chief gone."
